Anthony DeFelice, Monongalia County Health Department Executive Director, thanked the Commission for passing the rates and introduced the new Health Officer Dr. Brian Huggins. The retiring Health Officer Dr. Lee Smith thanked the Commission for their support over the years.

c) A motion was made by Commissioner Arnett, seconded by Commissioner Bloom and unanimously carried to approve Requisition No. 89 for the University Town Centre Economic Opportunity Development District Subaccount in the amount of \$798,781.01.

d) A motion was made by Commissioner Arnett, seconded by Commissioner Bloom and unanimously carried to approve Requisition No. 8 for the University Town Centre Series 2023 A Property Tax District Administrative Expense Fund in the amount of \$4,034.60.

e) A motion was made by Commissioner Arnett, seconded by Commissioner Bloom and unanimously carried to approve Requisition No. 86 for the University Town Centre Excise Tax District Administrative Expense Fund in the amount of \$2,372.50.
